RE: Codan Limited (CDA)

In completing its 30 June 2007 year end accounts it has come to the attention of Codan Limited, that it has failed to lodge some notices in relation to ASX Listing Rules 3.19 A.1, A.2 and A.3. These rules relate to the disclosure of Directors' initial interests in securities, changes to Directors' interests, and interests in securities of Directors at cessation of being a Director.

Codan wishes to correct these oversights that have resulted from administrative errors.

Codan has reviewed its processes to ensure that such oversights do not occur in the future. In this regard the Board has amended its processes relating to Director communications of security holdings and transactions such that all initial and final holdings and any security transactions whilst a Director must now be:

- communicated to both the Company CEO and Company Secretary,
- in writing; and
- within 3 business days.

This allows the Company 2 days to confirm all details and lodge the required notices to the ASX within prescribed periods.

In correcting these oversights Codan wishes the market to note however:

- all Director's shareholding information disclosed in the annual year end accounts of 30 June 2004, 2005, and 2006 were correct;
- no Director has sold any Codan securities during the times of non-compliance; and
- all security purchases by Director's were within time periods prescribed by Codan's Share Trading Policy
